What is Women's and Gender Studies

▶ Women's and Gender Studies is an interdisciplinary program that examines the multiple roles gender plays in everyday life, the impacts of gendered practices on social, cultural, and political behavior and thought, and the intersections of gender, race, sexuality, ability, age, and class.

LSU's Program Description

- ▶ Women's and Gender Studies (WGS) is an interdisciplinary area
- WGS teaches students to understand and critique the formation of categories of gender, gender identity, and sexuality as they function in social, economic, cultural, and/or political contexts
- ▶ WGS considers **gender and sexuality** as they intersect with other categories of difference, such **as race**, **ethnicity**, **class**, **nationality**, **and ability**
- ▶ WGS emphasizes the importance of thinking about problems from diverse perspectives, and to applying feminist and queer critical perspectives to new questions across disciplines
- ▶ WGS trains students to **communicate effectively** using gender- and sexualitybased frames of analysis as a tool for academic research, creative production, collaborative work, and social change

LSU's Program Description

- ▶ WGS's emphasis on diversity teaches students to think about ways to meet the needs and address the concerns of multiple groups in society.
- Students in WGS go on to careers in multiple fields including law, education, social work, health, mass communications, and many more.
- ► The WGS concentration or minor serves as an ideal complement to many majors and minors.
- ▶ WGS is committed to the 3+3 program

Course Topics

- Our courses examine topics such as
 - Women and LGBTQ persons in culture and history;
 - How assumptions about gender and/or sexuality operate in society, shaping masculine, feminine, trans, gay, lesbian, bisexual, asexual, nonbinary, and queer identities;
 - ► History and cultural analysis through the an intersectional-aware lens that considers gender, race, class, ability, nationality, and sexuality in context with one another;
 - Gender and sexuality in literature, politics, the law, the sciences, and other cultural fields
- Our courses are diverse, multi-disciplinary, and the concentration provides students with many elective options

Undergraduate Concentration

- Required courses for the B.A. in Liberal Arts with a Concentration in WGS
- As a student pursuing a Bachelor of Arts (B.A.) in Liberal Arts with a Concentration in Women's and Gender Studies, you will be required to complete 36 hours of course work, including:
- ◆ WGS 2900, "Gender, Race, and Nation" (3 credit hours);
- ◆ WGS 3150, "Survey of Feminist Theory" (3 credit hours);
- ◆ WGS 4500, "Special Topics in Women's and Gender Studies" (6 credit hours).
- An approved cross-cultural course is also required (3 credit hours).
- You must also complete 18 additional hours of electives.
 - ◆ These electives should be WGS-approved social science/humanities electives.
 - ◆ Of these elective courses, 9 hours must be at the 3000 level or above.
 - You should contact the WGS undergraduate adviser to ensure your electives are eligible for degree credit.

Undergraduate Minor

- Required courses for the undergraduate minor in WGS As a student pursuing an undergraduate minor in Women's and Gender Studies, you will be required to complete 18 hours of coursework, including
- WGS 4500, "Special Topics in Women's and Gender Studies" (3 Credit Hours)
- You must also complete 12 hours of electives, at least 9 hours of which must be at the 3000 level or above.
 - ◆ The minor electives should be chosen from at least two of the following areas:
 - ← Literature: ENGL 2593, 3593, 4593; FREN 4090, 4095; SPAN 4100
 - Culture & Society: ENGL 4493; CLST 2080; HIST 4079; REL 3300; SOCL 4413, 4521; CMST 3115
 - ◆ Theory: ENGL 4593; PHIL 4015; WGS 3150

Graduate Minor

- ▶ Students minoring in WGS must complete 12 semester hours of course work including 6 hours at the 7000 level
 - ► (Choose two of these three: WGS 7150, WGS 7500 and WGS 7900) and 6 hours in WGS.
 - ▶ Of these courses, no more than two may be taken within the same department or with the same professor and no more than one course may be taken within the student's home department.
