Your 2018-2019 application for federal student aid has been selected for verification. As part of the verification process, the financial aid office is required to collect and verify certain 2016 income information. Based on the 2016 tax return transcript we received, it appears your father was involved with a partnership in 2016. In order to verify any self-employment income earned from the partnership, a copy of Schedule K-1 Form 1065 is needed. This form would have been produced by the partnership information, and is used to assist in filing personal income taxes. It is not part of the individual income tax return.
