PARENT 2017 FEDERAL TAX RETURN TRANSCRIPT REQUEST

Your 2019-2020 application for federal student aid has been selected for verification of 2017 tax information. Please submit all required documentation listed below for your parents. Failure to submit all required documents will result in a delay in the processing of your aid. Information is needed for both parents if on the date your FAFSA was filed, your parents were married/re-married or unmarried but living together. **The student's name and LSU ID should be listed on all documents submitted.**

REQUIREMENT #1

Submit a 2017 IRS Tax Return Transcript* (Transcripts are typically front and back. Please be sure to send a copy of all pages.)

- May be requested online at irs.gov and selecting "Get Your Tax Record" or by calling 1-800-908-9946.
 Make sure to request the "Tax Return Transcript" and NOT the "Account Transcript".
- If an amended tax return was filed, submit a **signed** copy of the 1040X "Amended U.S. Individual Income Tax Return" **and** a 2017 IRS Tax Return Transcript.
- If an individual filed or will file a 2017 income tax return with Puerto Rico, another U.S. territory, or with a foreign country, must provide:
 - o A signed copy of the 2017 income tax return(s); or
 - A transcript obtained from a government of a U.S. territory or commonwealth; or a foreign central government that includes all of the tax filer's income and tax information required to be verified for tax year 2017.

Quick facts about the IRS Tax Return Transcript:

- To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- Individuals can request their tax transcript as soon as the IRS processes their return.
- Applicants requesting the transcript to be mailed should receive the transcript within 5 to 10 calendar days after their request.
- It's FREE! No one should be charged for obtaining an IRS Tax Return Transcript.

REQUIREMENT #2

Submit copies of all 2017 W-2 forms

Amount(s) reported in Box 1 of W-2 forms should total 'Wages, Salaries, Tips, Etc.' reported on the Tax Return Transcript. If amount(s) from forms other than a W-2 are included on this line, please submit those additional documents as well.

REQUIREMENT #3

Submit a copy of Schedule K-1 Form 1065, if applicable

• This form is only required for tax filers who have Partnership Income reported on Schedule E of the 1040 filed
