LDWF Enforcement Division Academy

The Louisiana Department of Wildlife and Fisheries' (LDWF) Law Enforcement Division will begin training up to 24 cadets in May of 2015 to bolster the ranks of agents in the field.

The cadets will train at the department's training facility housed within the Waddill Outdoor Education Center in Baton Rouge. Successful completion of six months of intensive physical and academic training is required to graduate.

LOUISIANA REGULATIONS

Commercial King Mackerel Season

The 2015 commercial king mackerel season will open July 1. Once the season opens, it will remain open until the quota is met or projected to be met.

King mackerel is a significant commercial fishery in Louisiana. From 2000 through 2013, Louisiana landed on average an amount equal to approximately 75 percent of the allotted western Gulf of Mexico quota. In 2013, approximately 731,000 pounds were landed in Louisiana. A significant amount of the king mackerel landed in Louisiana is shipped to markets in the northeastern U.S.

Fall Shrimp Season

A closure of the fall shrimp season in remaining state inside waters and in a portion of state outside waters was effective Wednesday, Jan. 28, 2015, at official sunset.

Specifically, those waters closed to shrimping include:

- Lake Pontchartrain, Chef Menteur and Rigolets Passes, Lake Borgne, Mississippi Sound and the Mississippi River Gulf Outlet (MRGO)
- The portion of state outside waters extending a distance of three nautical miles seaward of the inside/outside shrimp line from the northwest shore of Caillou Boca at -90 degrees 50 minutes 27 seconds west longitude westward to the Atchafalaya River Ship Channel at Eugene Island as delineated by the channel red buoy line

The following state waters remain open to shrimping until further notice:

- The open waters of Breton and Chandeleur Sounds as described by the double-rig line in R.S. 56:495.1(A)2
- All state outside waters east of Caillou Boca as well as all state outside waters west of Freshwater Bayou Canal
- □ All fishery jurisdiction waters claimed by the state beyond the three nautical mile closure zone

GULF OF MEXICO REGULATIONS

Comments Sought for Two Recreational Sub-Quotas for Gulf of Mexico Red Snapper

NOAA Fisheries is seeking public comment on a proposed rule that would establish distinct private angling and federal for-hire sub-quotas for red snapper. These measures are outlined in Amendment 40 to the Fishery Management Plan for the Reef Fish Resources of the Gulf of Mexico submitted by the Gulf of Mexico Fishery Management Council. The proposed rule published in the *Federal Register* on Jan. 23, 2015, with the comment period ending March 9, 2015.

Proposed Management Measures

The rule would establish sub-quotas for federally permitted for-hire vessels and private anglers who fish for red snapper for a three-year period beginning in 2015.

- □ The federal for-hire component would be comprised of all for-hire operators with a valid or renewable federal reef fish charter vessel/headboat permit.
- □ The private angling component would be comprised of private recreational anglers and other for-hire operators who do not have a federal reef fish charter vessel/headboat permit.

The rule would implement sub-quotas from the 5,390,000-pound red snapper recreational quota using Amendment 40's allocation of 42.3 percent to the federal for-hire component and 57.7 percent to the private angling component.

- □ The federally permitted for-hire quota would be 2,279,970 pounds.
- □ The private angling quota would be 3,110,030 pounds.

Finally, the rule would establish separate red snapper annual catch target and season closure provisions for the federal for-hire and private angling components. For both components, each season would start June 1 and continue until the individual component's annual catch target is projected to be caught.

King Mackerel, Spanish Mackerel, and Cobia Regulations

A new rule effective March 1, 2015, will change regulations for king mackerel, Spanish mackerel, and cobia. The rule will:

- Eliminate the 500-pound trip limit that is effective when 75 percent of the respective quotas are landed for king mackerel in the Florida west coast Northern and Southern Subzones.
- Change the fishing year for king mackerel in the Florida west coast Northern Subzone to October-September beginning Oct. 1, 2015. Currently, the fishing year is July-June.
- □ Allow transit of commercial vessels with king mackerel through areas closed to king mackerel fishing, if gear is appropriately stowed.
- Create Northern and Southern Zones for Atlantic migratory group king and Spanish mackerel, each with separate quotas. NOAA Fisheries will close each zone when the respective quota is met or expected to be met. The dividing line between the zones is at the North Carolina/South Carolina state line.

- Make administrative changes to the framework procedure for modifying management measures.
- □ Increase annual catch limits and catch targets for cobia.
- Create a Florida East Coast Zone for cobia to adjust for differences between the Councils' jurisdictional areas and the biological distribution of the Gulf of Mexico and Atlantic stocks. This zone will have its own quota, and NOAA Fisheries will close the zone when the quota is met or expected to be met.

There were nine paid and two denied.






Louisiana Shrimp Watch



Joe Patti's Hot Crab Dip

Ingredients:

Ib blue crab meat
Ib cream cheese, softened
bunch green onions, green and white parts finely chopped
cup mayonnaise
teaspoon Worcestershire sauce
splashes hot sauce

1/2 up almonds, sliced, lightly toasted Crackers or pita chips for serving

Method:

Heat oven to 350°F. Blend crab, cream cheese, green onions, mayonnaise and Worcestershire sauce in the bowl of electric mixer. Scrape down sides of bowl and stir in hot sauce. Spray a 1-quart glass baking dish with nonstick spray. Spoon crab mixture into dish and spread almonds over the top. Bake until edges are bubbly, 20 to 30 minutes.

Serve with crackers or pita chips.
