

## 2015 Fishery Legislative Summary

The following is a summary of some of the House and Senate bills that affect the fishing industry. Details, current status, and full text can be found at <u>http://www.legis.la.gov/legis/BillSearch.aspx</u>.

HB198: St. Germain. Status: Pending Legislative Bureau; Passed House

FISHING/CRABS: Increases fees for participation in the commercial crab fishery from \$35 to \$50 for a resident commercial crab trap gear license. Nonresident gear license fees would increase to \$200.

HB303: Gisclair. Status: Passed House and Senate; Signed by the Speaker

FISHING/FINFISH: Provides relative to the method of determination of a stock assessment for black drum, sheepshead and flounder.

HB332: Billiot. Status: Passed House and Senate; Signed by the Speaker

FISHING/CRABS: Expands eligibility for a commercial crab trap gear license to holders of a seafood dealer's license who can document appropriate crab landings between 2011 and 2014.

HB341: Garofalo. Status: Passed House and Senate

FISHING/OYSTERS: Provides for additional penalties for unauthorized taking of oysters from leased acreage.

HB438: Lambert. Status: Pending House Natural Resources

FISHING/CRAWFISH: Sets penalties for minimum size violations for live crawfish sold for direct human consumption.

HB579: Garofalo. Status: Pending Legislative Bureau

FISHING/OYSTERS: Increases lease rental rates for oysters leases from \$2 to \$3 per acre per year.

HB668: Hill. Status: Pending Legislative Bureau; Passed House

FISHING/SHRIMP: Repeals the prohibition on enforcement of the federal rules on the use of turtle excluder devices in shrimp trawls used in state waters.

HB680: Leopold. Status: Pending House Natural Resources

FISHING/OYSTERS: Provides relative to private oyster leases on privately owned water bottoms.

HCR104: Dove. Status: Pending Senate floor action; Passed House

FISHING/OYSTERS: Creates the Oyster Lease Moratorium Lifting Committee.

HCR138: Lambert. Status: Involuntarily deferred in House Natural Resources FISHING/CRAWFISH: Creates a study committee to study issues surrounding both the farm-raised and wild-caught crawfish industries.

HCR140:Lambert. Status: Pending Senate Natural Resources

FISHING/CRAWFISH: Urges the Department of Wildlife and Fisheries to examine the issue of a wildcaught crawfish fishing season.

SB254: Crowe. Status: Pending Senate Natural Resources

WILDLIFE/FISHERIES DEPT: Authorizes an alternative for identification for the purchase of a resident fishing and hunting license.

SCR66: Chabert. Status: Sent to the Secretary of State

FISH/FISHING: Memorializes Congress to take action against illegal, unreported and unregulated fishing in Louisiana's sovereign waters by passing H.R. 774, the Illegal, Unreported, and Unregulated Fishing Enforcement Act of 2015.

#### LOUISIANA REGULATIONS

#### Louisiana spring shrimp season

The 2015 Louisiana inshore shrimp season opened statewide at 6 a.m. on May 18, as well as that portion of state outside waters extending three nautical miles seaward from the shoreline from the Atchafalaya River Ship Channel at Eugene Island as delineated by the Channel red buoy line westward to the to the western shore of Freshwater Bayou Canal at -92 degrees 18 minutes 33 seconds west longitude.

In addition to the open waters of Breton and Chandeleur Sounds, all state outside waters are currently open to shrimping except for outside waters extending three nautical miles seaward from the shoreline from the Atchafalaya River Ship Channel at Eugene Island westward to the to the western shore of Freshwater Bayou Canal.

The Louisiana Department of Wildlife and Fisheries (LDWF) provided projections of the dates when a minimum of 50 percent of the inshore brown shrimp population would reach sizes of 100 count per pound or larger. LDWF reminds fishermen that federal Turtle Excluder Device (TED) regulations require skimmer net fishermen to limit tow times. Maximum tow times are 55 minutes from April 1 through Oct. 31 and increase to 75 minutes from Nov. 1 to March 31.

## Commercial Fishing Season for Large Coastal Sharks Closed in Louisiana Waters

Effectively immediately, commercial fishing for large coastal sharks is closed in Louisiana waters. The National Marine Fisheries Service also closed commercial fishing for large coastal sharks in federal waters of the Gulf of Mexico. The season will remain closed in state and federal waters until Jan. 1, 2016, when the season is scheduled to reopen. The season for the commercial harvest of small coastal sharks in Louisiana waters remains open at this time.

During the closed season, all commercial harvest, possession, purchase, exchange, barter, trade, sale or attempt to purchase, exchange, barter, trade or sell large coastal sharks or their fins is prohibited.



Vessels that have been issued or that possess a federal shark research permit may continue to operate under the conditions of that permit, which includes the presence of designated NOAA Fisheries observers aboard the vessel for the duration of the trip, until the quota for the federal shark research fishery is achieved.



## The Gumbo Pot

## Pan Fried Grouper

## Ingredients:

2 medium sized grouper fillets 2 large eggs 1½ c. flour 1¼ tsp. salt 1/4 tsp. white pepper, freshly ground best 1/8 tsp. cayenne 1/4 c. (1/2 stick) salted butter 1/4 c. olive oil 1/3 c. shallots, minced 1 bay leaf 3/4 tsp. dry marjoram

## Method:

Rinse the fillets and dry on paper towel. Combine eggs and 2 tablespoons cold water in a pie dish and beat lighty with a fork. Combine the flour, salt, pepper and cayenne in another bowl and mix well. Dip fillets in egg and water mixture then roll them in the seasoned flour to coat all sides. Place them on a platter - not touching - to let dry for 5 minutes.

In a large skillet melt the butter over medium heat, mix in the olive oil with a wooden spoon and continue cooking until the oil is quite hot. To test oil shake a small drop of water on oil if it skates and dances across then oil it is hot enough. Fry the fillets until browned about 3 to 4 minutes per side. Add the shallots, bay leaf and marjoram to the oil in the spaces around the sides of the fish fillets after the fish begins to brown on the first side. When the fish is done on both sides remove it to a paper towel lined platter. Continue to let the sauce in pan simmer for another 3 minutes. Serve the fillets with about 2 to 3 tablespoons of sauce from the pan.
